IT AIMS AT

- b) Enabling a child to explore from his/her environment that knowledge which would prepare him/her facing challeges of modern life without spoon-feeding from his/her teachers.
- Developing a rational and scientific outlook on life and acquiring thirst for knowledge.
- d) Inculcating the fundamental values of life like compassion, tolerance, truth, honesty, love for his fellow beings and respect for our ancient thought & cultural heritage.

Above all, the D.A.V. Public School believes in inherent discipline. However, it expects each and every one to abide by the rules and regulations of the school. The students are to observe strict discipline not only inside the school but also out-side and bring a good name to the school. The co-operation of parents and guardians is highly essential in the development of the child.

With all these aims and objectives in view, a D.A.V. Public School as already stated is established at Sangakpham, Imphal. The School is affiliated to the Central Board of Secondary Education, New Delhi upto the Senior Secondary Stage (Class - XII) (Affiliation No. 1230004) and is under the direct control of D.A.V. College Managing Committee, Chitra Gupta Road, New Delhi.

As per our convenience we have opened only Science Stream. However, efforts shall be made to start Humanities also if the number of the candidates increases.

THE D.A.V. POLICY OF EDUCATION

1. To make education national in tone and character and weld together the Indian people by encouraging the study of the national language (Hindi) and acquaintance with English literature.



- 2. To impart knowledge and develop in students, faculty of thinking and a spirit of enquiry and research, so as to make them useful members of the community.
- 3. To infuse in students high moral and spiritual values by enforcing the study of Sanskrit and Vedas in D.A.V. Institutions.
- 4. To afford stimulus to the material and economic progress of the country by spreading knowledge of the physical applied sciences and introducing education.

CURRICULUM

In order to develop the language ability, three language formula as per the education policy of the Central Government has been adopted. English, Manipuri and Hindi are taught from Nursery Classes and Sanskrit from Class V onwards. The other academic subjects are Science, Maths., Social Studies, etc. Bisides the other co-curricular activities, Music, Dance, Art, General Knowledge, Debating and the like shall be taught. However, emphasis is given on the development of physical and intellectual faculties through games, sports and yoga. The main feature on the whole of the School is to create national awareness, unity and integrity through different types of programmes like School Welfare and Civic Responsibility, etc.

EXAMINATION

Periodic Tests, Half Yearly Examination form integral part of the student's achievements. Apart from the Annual Examination, weightage is given for all the Tests and Half Yealy Examination on the cumulative result of which the promotion of a student to the next higher class is decided at the end of the School session. No student who fails for two consecutive years or three times in his/her career in the school will be kept in the school.

Performance of Class X and XII students are assessed continuously, but the qualifying test in the month of December/January and percentage of attendance will determine their eligibility to appear at the Board's final examination.

ATTENDANCE

- a) A pupil will be eligible to appear in the Session Ending Examination if he/she has completed 75% attendance.
- b) Leave to a student for absence is granted only on an application addressed to the Principal through Class Teacher submitted in time (definitely the same day, rarely the next day in unavoidable circumstances) duly attested by the parent/guardian, if parent is not with the student.
- c) The period of leave with reasons should also be recorded in the Student's Diary by the parent with signature.
- d) In case of illness, a Medical Certificate must be attached with the application. Long absence except in case of illness should be discouraged.
- e) The name of the candidate shall be struck off the rolls of the register if he/she is absent for more than a week continuously without sanction of leave.



HOUSE SYSTEM

For various co-curricular activities of the School children are divided into four major houses viz:

- c) AZAD HOUSE
- b) HANS RAJ HOUSE
- d) THANGAL HOUSE

Each house has an Incharge and House Captain. Various Committees comprising teachers are formed for different competitions in Annual Sports Meet and Literary Meets. The performance of each of the student and houses are recorded. The students are awarded with various prizes on the Annual Prize Distribution Day.

MEDICAL CHECK-UP

Arrangement is made for periodical medical check-up by a Medical Officer.

GAMES & SPORTS

To inculcate harmonious development in the child we lay stress in healthy mind in a healthy body. A special trained teacher takes care of this item.

VISITS OF PARENTS/GUARDIANS

Parents/guardians are med welcome to visit the School on working days to discuss the progress of their ward/wards with the Principal and the concerned subject teachers. Visitors require to seek permission of the Principal to meet any student. Visitors, however, are not allowed to meet their ward/wards while classes are in progress.

GENERAL RULES & DISCIPLINE

- Every student of the school is required to come to school in clean & complete School uniform daily. Students (boys) are instructed to keep a clean short hair-cut.
- Students must reach the school before the first bell is rung & take part in the Morning Assembly.



- 3. Every student must extend help in keeping the class-room & the school campus clean. Never disfigure the walls or damage the school furniture and other property. For any damage to the school property, a fine which commensurate to the extend of damage shall be imposed on the student(s) responsible for it.
- 4. Bring the **Text-Books and Note/Exercise Books** only. No Magazine, papers and book of objectionable nature shall be brought to the school.
- 5. Take care of your things. Students are responsible for the safe custody of their books and other belongings.
- 6. Every student must possess school Diary & Identity Card and must bring to school daily. Students without Diary & Identity Card will not be allowed to enter the class. Enter home-works in the diary regularly and do the work regularly.
- Every student must be an active participant in every school activity.
- 8. Any person including parents/guardians is not allowed to pick up or meet child/ward during the school hour without prior permission from the Principal.
- Bunking from class or leaving the school during the school hour without the knowledge of the authority is strictly prohibited.
 If any, such student shall be duly punished.
- Indiscipline, insubordination, disrespect to any teacher or staff
 member by the student shall not be tolerated.
- 11. Smoking, chewing pan, taking talab, drinking etc. are strictly prohibited. If any one of the students is found indulging in such bad habits, he/she is liable to be punished with expulsion from the school.
- 12. **Mobile Phone** is strictly prohibited. If found in the school, the same will be forfeited.
- 13. Students are not allowed to bring two wheelers or any vehicle in the school.
- 14. Every student should maintain strict discipline and behave decently inside and outside the school.
